Description

This plan provides a discount on direct dialed station international calls placed to the one international country or area which has been designated by you to receive the discount provided with this plan.

Terms and Conditions

1. **To participate in this plan, you must:**
 - Currently have, or choose AT&T as your Primary Long Distance Carrier.
 - Have designated one international country per main billed account to receive an international discount on direct dialed station calls to that country. This designated international country selected by you must have AT&T direct dialed station service.
 - Enroll in this plan by doing one of the following:
 - Complete the online subscription form to AT&T.
 - Call our AT&T Customer Care Center at 1-888-795-2717 to subscribe.
2. **This plan includes the following types of calls:**
 - AT&T direct dialed station international calls that are:
 - made from your home,
 - billed to your main residential telephone account, and
 - made without using an AT&T Operator or an AT&T automated call processing system.
 - Direct dialed station international calls originating from the US Mainland, Puerto Rico or the US Virgin Islands and terminating in foreign countries or areas where AT&T service is available.
 - All other types of calls are rated at basic rates unless you are enrolled in another AT&T plan that covers these other types of calls.
3. **AT&T will provide the benefits of this plan until one or more of the following events occur:**
 - AT&T changes and/or discontinues this plan.
 - AT&T is notified that you no longer subscribe to AT&T as your Primary Long Distance Carrier. Discontinuance will be effective as of the date AT&T's records show that you no longer subscribe to AT&T.
 - You notify AT&T that you want to withdraw from this plan.
4. **You can enroll in only one state-to-state pricing plan for AT&T direct dialed station calls for each main residential telephone account unless AT&T notes otherwise.**



5. **AT&T will bill for this plan based on the following:**

- Duration of each call is recorded in whole minutes, with partial minutes rounded up to the next whole minute (for example, a 45-second call will be billed as a one-minute call).
- Usage rates are per minute, per country and are based on time of day. For some countries, as identified on the rate tables, the rate may be based on time of day and day of week.
- If a call originates from the US Mainland, Puerto Rico or the US Virgin Islands during one rate period, but concludes in another rate period, the rate applicable at the start of the call applies to the entire call.
- Initial and additional minute usage rates apply. The first minute of the call will be rated at the Initial Minute rate and each additional minute, or fraction thereof, of a call will be rated at the Additional Minute rate.
- Rates for calls from US Mainland to Canada are based on mileage.
- Rates for calls from US Mainland to Mexico and based on mileage from the US location to the border and on bands from the US border to telephone number in Mexico. The Mainland/Mexico call includes both a mileage rate and band rate. For additional information, see [AT&T Mexico Rate Band Description](#).
